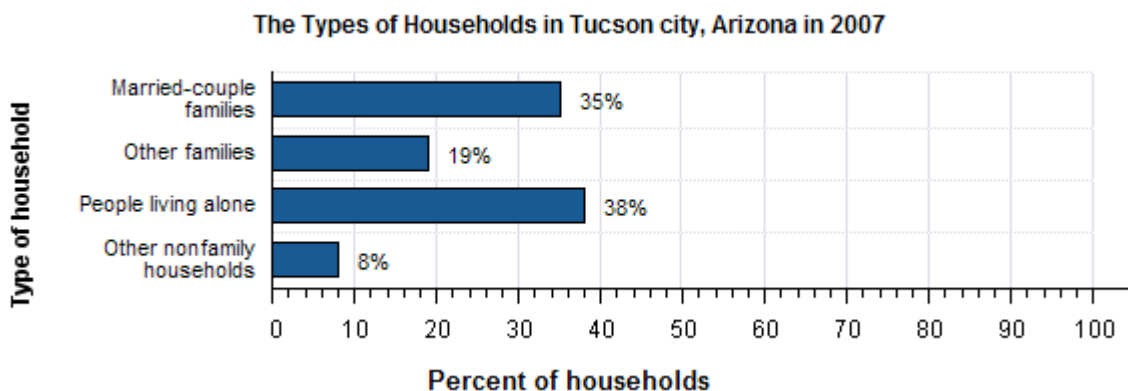

**HOUSEHOLDS AND FAMILIES:** In 2007 there were 207,000 households in Tucson. The average household size was 2.4 people.

Families made up 54 percent of the households in Tucson. This figure includes both married-couple families (35 percent) and other families (19 percent). Nonfamily households made up 46 percent of all households in Tucson. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

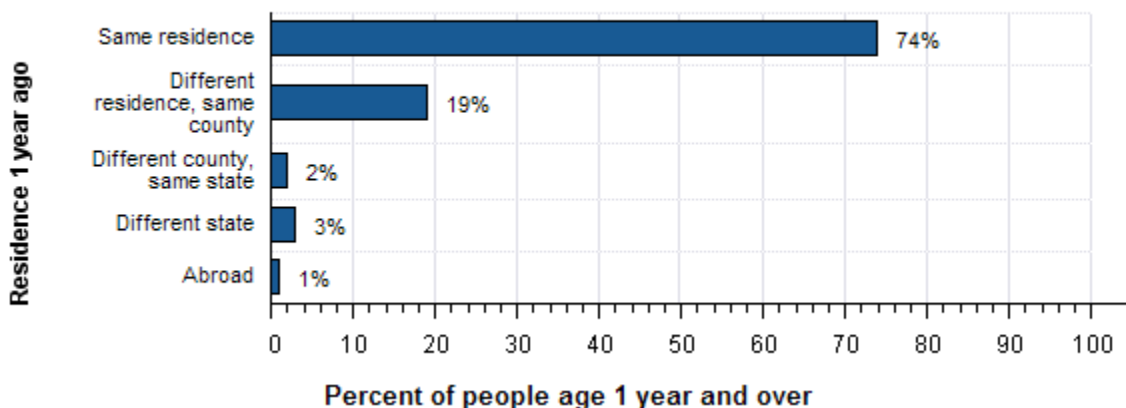


**NATIVITY AND LANGUAGE:** Seventeen percent of the people living in Tucson in 2007 were foreign born. Eighty-three percent were native, including 40 percent who were born in Arizona.

Among people at least five years old living in Tucson in 2007, 36 percent spoke a language other than English at home. Of those speaking a language other than English at home, 85 percent spoke Spanish and 15 percent spoke some other language; 38 percent reported that they did not speak English "very well."

**GEOGRAPHIC MOBILITY:** In 2007, 74 percent of the people at least one year old living in Tucson were living in the same residence one year earlier; 19 percent had moved during the past year from another residence in the same county, 2 percent from another county in the same state, 3 percent from another state, and 1 percent from abroad.

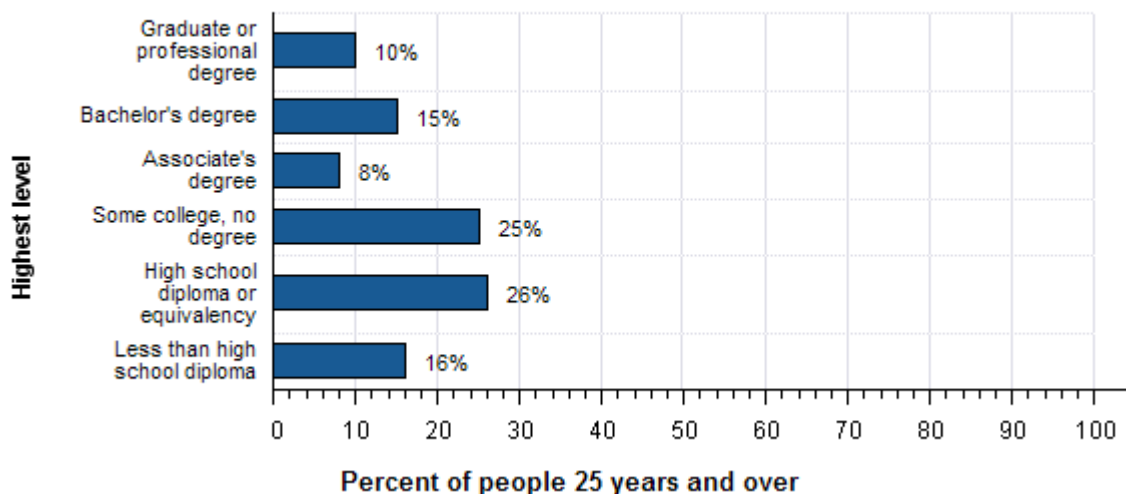
**Geographic Mobility of Residents of Tucson city, Arizona in 2007**



**EDUCATION:** In 2007, 84 percent of people 25 years and over had at least graduated from high school and 25 percent had a bachelor's degree or higher. Sixteen percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Tucson was 145,000 in 2007. Nursery school and kindergarten enrollment was 13,000 and elementary or high school enrollment was 78,000 children. College or graduate school enrollment was 55,000.

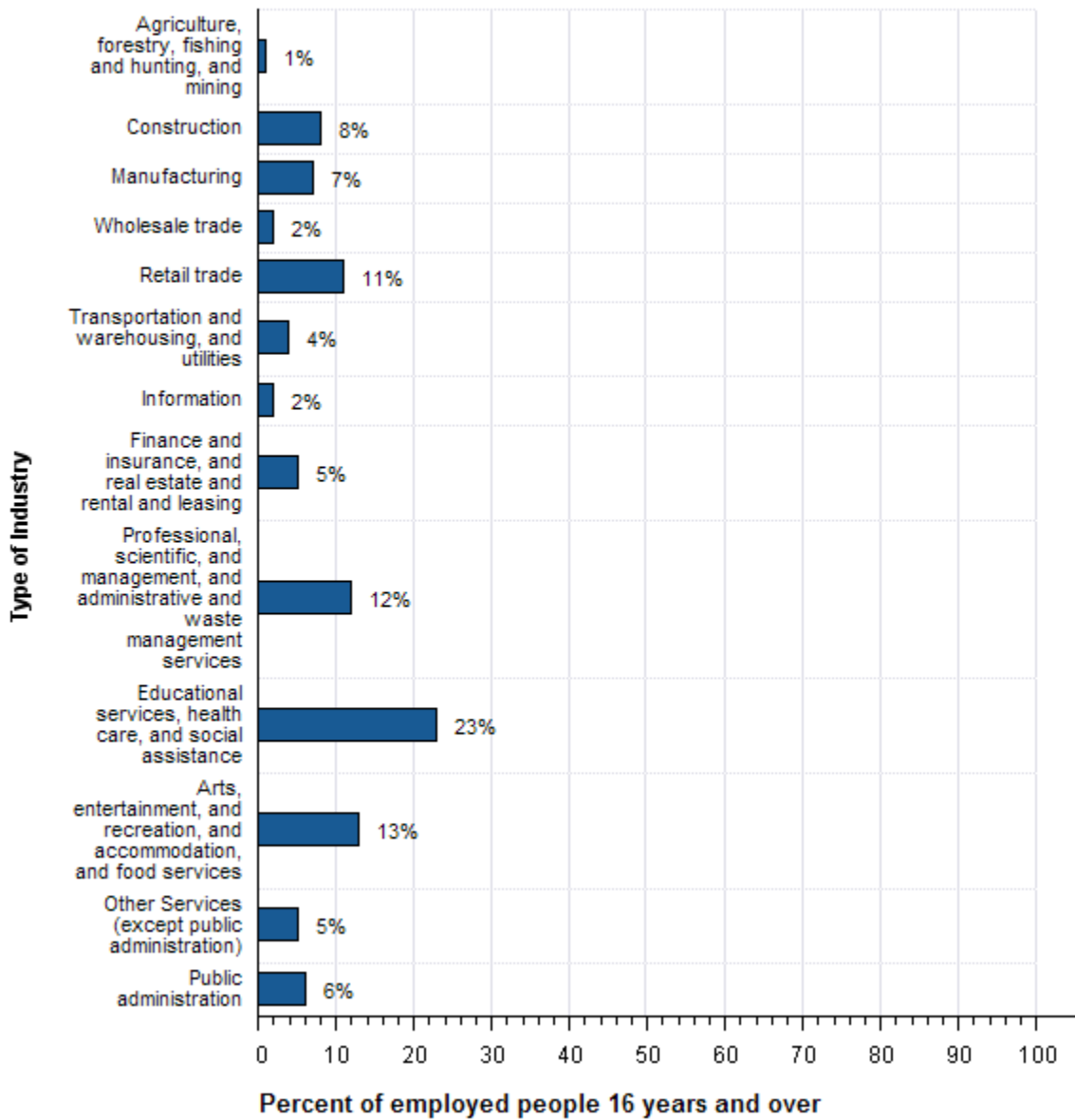
**The Educational Attainment of People in Tucson city, Arizona in 2007**



**DISABILITY:** In Tucson, among people at least five years old in 2007, 17 percent reported a disability. The likelihood of having a disability varied by age - from 8 percent of people 5 to 15 years old, to 14 percent of people 16 to 64 years old, and to 45 percent of those 65 and older.

**INDUSTRIES:** In 2007, for the employed population 16 years and older, the leading industries in Tucson were educational services, and health care, and social assistance, 23 percent, and Arts, entertainment, and recreation, and accommodation, and food services, 13 percent.

**Employment by Industry in Tucson city, Arizona in 2007**

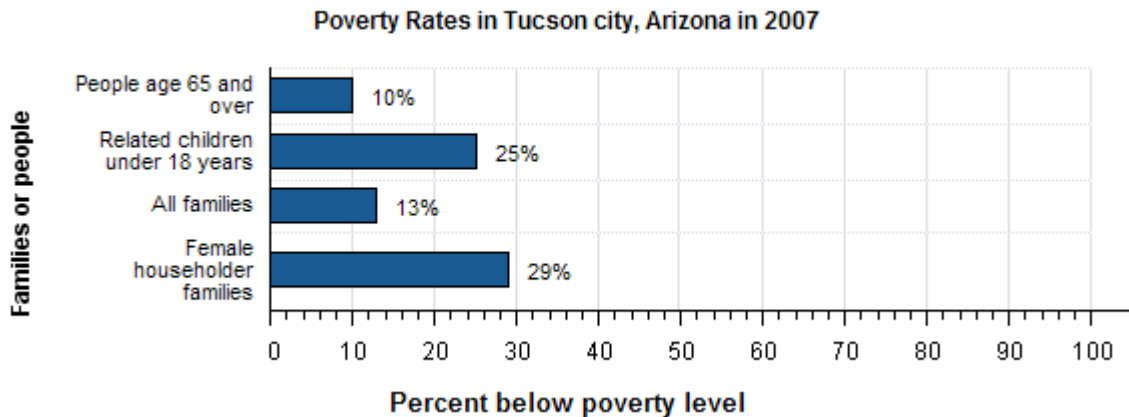


**OCCUPATIONS AND TYPE OF EMPLOYER:** Among the most common occupations were: management, professional, and related occupations, 30 percent; sales and office occupations, 25 percent; service occupations, 23 percent; construction, extraction, maintenance and repair occupations, 11 percent; and production, transportation, and material moving occupations, 10 percent. Seventy-five percent of the people employed were private wage and salary workers; 19 percent were federal, state, or local government workers; and 6 percent were self-employed.

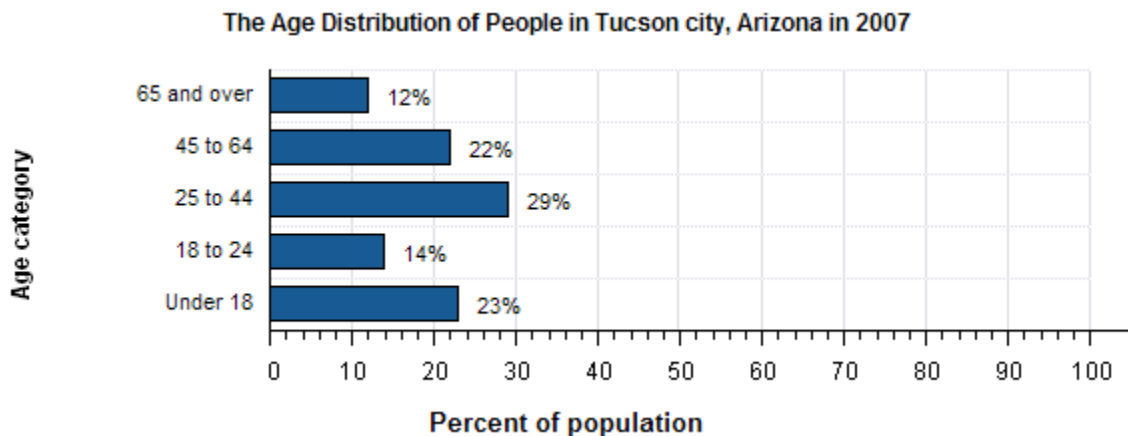
**TRAVEL TO WORK:** Seventy-four percent of Tucson workers drove to work alone in 2007, 11 percent carpooled, 3 percent took public transportation, and 8 percent used other means. The remaining 4 percent worked at home. Among those who commuted to work, it took them on average 21.4 minutes to get to work.

**INCOME:** The median income of households in Tucson was \$36,096. Seventy-nine percent of the households received earnings and 16 percent received retirement income other than Social Security. Twenty-six percent of the households received Social Security. The average income from Social Security was \$13,306. These income sources are not mutually exclusive; that is, some households received income from more than one source.

**POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS:** In 2007, 18 percent of people were in poverty. Twenty-five percent of related children under 18 were below the poverty level, compared with 10 percent of people 65 years old and over. Thirteen percent of all families and 29 percent of families with a female householder and no husband present had incomes below the poverty level.

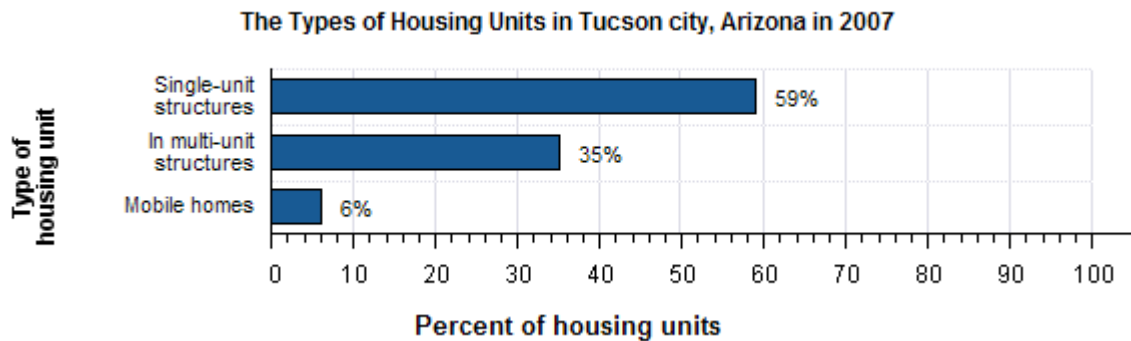


**POPULATION:** In 2007, Tucson had a total population of 519,000 - 263,000 (51 percent) females and 257,000 (49 percent) males. The median age was 33 years. Twenty-three percent of the population was under 18 years and 12 percent was 65 years and older.



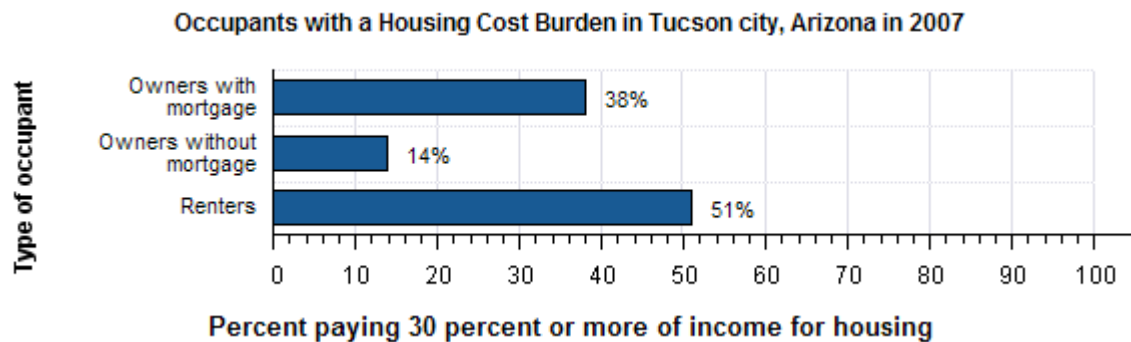
For people reporting one race alone, 67 percent were White; 4 percent were Black or African American; 2 percent were American Indian and Alaska Native; 3 percent were Asian; less than 0.5 percent were Native Hawaiian and Other Pacific Islander, and 23 percent were some other race. Three percent reported being of two or more races. Forty percent of the people in Tucson were Hispanic. Forty-nine percent of the people in Tucson were White non-Hispanic. People of Hispanic origin may be of any race.

**HOUSING CHARACTERISTICS:** In 2007, Tucson had a total of 232,000 housing units, 11 percent of which were vacant. Of the total housing units, 59 percent were single-unit structures, 35 percent were in multi-unit structures, and 6 percent were mobile homes. Twenty-four percent of the housing units were built since 1990.



**OCCUPIED HOUSING UNIT CHARACTERISTICS:** In 2007, Tucson had 207,000 occupied housing units - 109,000 (52 percent) owner occupied and 98,000 (48 percent) renter occupied. Seven percent of the households did not have telephone service and 12 percent of the households did not have access to a car, truck, or van for private use. Thirty-two percent had two vehicles and another 14 percent had three or more.

**HOUSING COSTS:** The median monthly housing costs for mortgaged owners was \$1,200, nonmortgaged owners \$322, and renters \$658. Thirty-eight percent of owners with mortgages, 14 percent of owners without mortgages, and 51 percent of renters in Tucson spent 30 percent or more of household income on housing.



**NOTE.**

The population and housing characteristics included above are derived from the American Community Survey.
